○ **How do we register our paralegals for the Organization Membership?**

In order to register for an Organization Membership, the account manager will need to contact NALA via phone or email.

○ **Are there eligibility requirements for the staff member's membership?**

The Organization Membership account manager is responsible for reviewing the eligibility requirements for Active type membership. By registering for the Organization Membership, the account manager confirms the staff has met those requirements.

○ **My organization has multiple offices/branches in multiple states. How can we take advantage of the Organization Membership?**

Organization Memberships can include staff from different business location branches. It does not matter how many branches are within the membership as long as one payment is submitted with the registration.

○ **What if I have already paid for an Individual NALA Membership?**

Payments already received for individual dues payments will be calculated proportionally and applied to the Organization Membership amount due.

○ **What will our renewal date be?**

The Organization Membership renewal date will be one year from the date your Organization Membership application and payment is processed.
